Shirts: John Holtz contacted Darryl Abraham regarding the shirts and logo. Shirts are available in sizes S-XX at a cost of \$15 each.

Books- we have approximately 26 painting and the book will be about 70 pages with anticipation of publication in the spring of 2023.

AJ Magnan reported that the comments have been published regarding the **National Park and Heritage Survey**. This may take a while as it has to be presented and passed in Congress.
